Dear Mr. Nirvan,

I have reasons to learn that certain office bearers of the Federation or the corporate members are depicting themselves as the office bearers of the AIKF, registered with Charity Commissioner for Greater Mumbai Region, Mumbai under the Bombay Public Trust Act, 1950.

In order to ensure fair and unbiased election of the federation I hereby direct you to communicate to all concerned copy of this letter with immediate effect.

I hereby direct all the office bearers or the corporate members who are illegally depicting themselves as the office bearer of AIKF, MUMBAI not to act or project themselves as any post holder of the Federation for it may seriously affect the ensuing elections and may affect the voters.

All the members and office bearers past or present are hereby directed that they shall henceforth not depict themselves as office bearers of the federation.

Further the last governing body approved after 2006 election was infused with a new lease of life only to declare the election process and since by means of Emergency Governing Body Meeting held on 9.1.2013 at hotel West End, Mumbai have resolved to declare the election and I have been appointed as the election officer, it has discharged its duties and they are no more an active executive now.
