**Sub:-**Your letter purportedly dated the January 3<sup>rd</sup>, 2013 written to Mr. P.R. Ramesh, where you have falsely claimed to be the President of the All India Karate Do Federation:-Reg

1. I am in receipt of the above captioned letter sent by you to one Mr. P.R. Ramesh and copy marked to me by e-mail, at the outset. I would like to bring that kind notice that you are unnecessarily trying to take undue advantage of the order's passed by The Deputy Charity Commissioner At Mumbai, without even knowing the contents and purport of the same, more particularly when the certified copy of the same has admittedly not been delivered to the respective parties.
2. You are hereby informed that the order never recognizes you or can recognize you as the President of the Federation or the said Mr. P.R. Ramesh as the General Secretary of the Federation. Hence you are hereby called

upon to desist from making such false representations in order to steal a march over the duly elected office bearers of the Federation. Merely because the change report filed by you and Mr. R Ganesh have been rejected , that does not mean that you continue to be the president of the Federation.

3. I hereby advise you to desist from making such false representations and there by attempting to mislead the karate fraternity, the duly elected office bearers of the karate fraternity are conducting the affairs of the Federation in the manner known to law.

4. Hence, I request you to stop sending such type of unnecessary communications in order to mislead and create confusion in the Federation, more particularly when the orders have not been delivered by The Deputy Charity Commissioner. In spite of the letter if you wish to proceed further, the same would be suitably dealt with in accordance with law, as admittedly your acts apart from being high handed are unauthorized and Void ab-initio, I would also like to bring your notice that by the above act of yours, you are trying to take advantage on the strength of the illegalities committed by you in collusion with others, which would be brought to the notice of the appropriate forum and appropriate action be taken against you and the persons, who are acting in collusion and connivance with you.

5. Hence, I request you to recall the above captioned letter with immediate effect and not to involve in such activities in future, which is admittedly against the interest of the Federation. More particularly when you have got nothing to do with the Federation as your purported term if any has expired long time back and your claim that you are the president of the Federation is wholly without any material basis and against The Memorandum of Association of the Federation.
