Sub: Appointing you as election officer of the National Sports Federation of Karate named All INDIA KARATE-DO FEDERATION of which elections are being held under court order at MUMBAI

Sir,

In above relation the undersigned would like to request you to take up the onerous task of conducting the election of a national federation of the sports of Karate named as AIKF for short.

It is submitted that the AIKF is a registered Federation and a Public Trust under the Bombay Public Trust Act, 1950 and was registered in year 1978 with PTR no. 4945(M) the federation was recognized by Government of India, Ministry of Sports as the National Sports Federation (NSF) for the game of Karate in India and subsequently by IOA also. But in the last five year after 2006 the federation is in doldrums due to mismanagement by some of the office bearers of the governing body.

There is also a parallel body using a same misnomer name of AIKF based in Tamil Nadu and few governing body member of the AIKF, Mumbai also joined hands with the Tamil Nadu based AIKF resulting in chaos. Two different change reports were filed with the Deputy Charity Commissioner bearing no. Dy CC no. 300/2008 and 569/2008 that were heard in time bound manner under the orders of Hon'ble Bombay High Court.

Owing to certain technicalities and due to the illegalities or the irregularities both the change reports have been dismissed by the learned Dy. Charity Commissioner, Greater Mumbai Region, Mumbai.

In the order dated 28.12.2012 the court of Dy. Charity Commissioner has held in its operative order thus:-

*"To avoid all above unfair practices and for the welfare as well as better administration of the AIKF, Mumbai in future, it is just and proper to declare the election program as per memorandum of association and rules and regulations of AIKF Mumbai, so I pass following order :-"*

## ORDER

1. *Change report no. 300/2008 and 569/2008 are rejected.*
2. *The Last governing body of "All India Karate Do-Federation, Mumbai" (PTR No. F-4945) elected as per meeting held on 11.4.2006 (Change Report 1445/2006 allowed on 1.10.2007) is directed to initiate the election process within 60 days from the date of this order as per the Memorandum of Associations and Rules and Regulations of AIKF, Mumbai, (PTR No. F-4945) under the supervision/ observation of Inspector Shir A. S. Khairkar of this office*
3. *In case of failure to commence the election process for the appointment/ election of the governing body within 60 days from the date of this order/ Inspector (Shri A.S. Khairkar) shall initiate the election process within 30 days as per Memorandum of Association and Rules and regulations of AIKF, Mumbai PTR no. 4945(Mumbai) and submit report accorsingly.*
4. *The election process as per reference in above clause no. 2 and 3 be held at registered office of the AIKF Mumbai at Mumbai or any other suitable place at Mumbai. ....*
