## ELECTION NOTIFICATION

Dear Corporate/ affiliated / members of AIKF , Mumbai,

As per the decision of Emergency Governing Body Meeting of All India Karate Do Federation which was held on 16th November, 2014 at Hotel Mohan International New Delhi, wherein it was resolved unanimously by the members present in the meeting that as per the Memorandum of Association, article 7, the term of the office bearers is for one year which is already over and hence a fresh election will have to be held in the next AGM.. Therefore it is hereby announced that the elections of the new Governing Body of AIKF, Mumbai will be conducted in the Annual General Body Meeting of AIKF which is going to be held on 2nd February, 2015 at Hotel Jaipur Green, Jai Singh Pura, Ajmer Road, Jaipur from 4.00 p.m. onwards.

In order to remove the confusion in the MOA, article, 6(b) which says "The President, *Secretary* or *Treasurer* may only hold office continuously for 2 terms of 4 years" it was resolved unanimously by all the members present that the term of the Treasurer will continue till the completion of four years as that of the President.

The election will be held for 13 Governing Body members and thereafter the election will be held for the following other office bearers. There shall be no election of President and Treasurer on that day as their term has not expired.

Since the Federation wishes to go for the new election process at the earliest, your cooperation is highly desired to help in preparation of the electoral list and clearing up of any dues owed by you, failing which you will not be allowed to take part in the election.
